Statistical overview

The aim of this overview is to present a number of key figures regarding migration and asylum in Denmark. For a monthly update of the main figures in this publication, please refer to the website <u>www.uibm.dk</u>.

2015

Summary

Migratory and asylum trends in 2015

In 2015 a total number of 84.693 residence permits were granted in the area of migration and asylum. The largest nationalities in 2015 were Syria (12.785), Romania (6.385), Poland (6.019), USA (4.302) and India (4.012).

An increase in the number of asylum seekers

The number of asylum seekers increased from 14.792 in 2014 to 21.316 in 2015. The largest nationalities in 2015 were Syria (8.608), Iran (2.787), Afghanistan (2.331), Eritrea (1.740) and stateless (1.734). These nationalities accounted for 81 percent of all asylum seekers.

The number of residence permits granted to refugees increased from 6.104 in 2014 to 10.849 in 2015.

The share of positive asylum decisions (the recognition rate) granted by the Danish Immigration Service (first instance) was 85 percent in 2015 compared to 74 percent in 2014.

Accommodation of asylum seekers

By the end of 2015 a total number of 17.145 persons were accommodated. In comparison 10.764 were in the accommodation system by the end of 2014.

At the end of 2015 a total number of 94 accommodation centres in 41 different municipalities were in operation, and the accommodation partners were: The Red Cross, the Regional Municipality of Bornholm, Vesthimmerland's Municipality, Jammerbugt Municipality, Langeland Municipality, Thisted Municipality, Tønder Municipality, the Danish Prison and Probation Service and the Danish Emergency Management Agency.

An increase in the number of residence permits granted on the basis of family reunification The total number of applications in the area of family reunification increased from 12.307 in 2014 to 16.017 in 2015. The largest nationalities in 2015 were Syria (6.872), Eritrea (1.511), stateless (1.073), Thailand (631) and the Philippines (529).

The number of residence permits granted on the basis of family reunification increased from 5.727 in 2014 to 11.645 in 2015. The increase can be detected in the number of permits granted on the basis of family reunification with a spouse or parents, who are beneficiaries of international protection. The number of permits granted on the basis of these reasons increased from 908 and 1.493 permissions respectively in 2014 and 2015 to 2.575 and 5.517.

The share of positive family reunification decisions relative to all decisions was 86 percent in 2015.

The largest nationalities in terms of family reunification permits were Syria (6.633), stateless (888), Thailand (425), the Philippines (361) and Somalia (331), corresponding to 74 percent of the total number of residence permits issued for family reunification.

Fewer permits issued in accordance with the Green Card Scheme accounts for a decrease in the number of permits granted on the basis of work activities in general

The total number of permits issued on the basis of work activities decreased from 12.436 permits in 2014 to 11.682 permits in 2015. The decrease is mainly a result of a reduction in the number of permits granted cf. the Green Card Scheme. In 2014 2.250 permits were issued, whilst the number was 1.243 in 2015.

In the area of work most permits were still granted accounting to the Pay Limit Scheme. The number of permits issued increased from 3.173 in 2014 to 3.295 in 2015. Furthermore, there has been an increase in the number of permits granted for the purpose of work activities in the agricultural sector from 570 in 2014 to 626 in 2015.

In 2015 739 residence permits were granted according to the Fast-Track Scheme, which was established simultaneously with a reform of the international recruitment efforts (IR- reform) by 1 January 2016.

30 percent of all permits issued in relation to work related activities in 2015 were granted to Indian citizens, which is in line with the fact that Indian citizens were the greatest beneficiaries of permits cf. the Pay Limit, Green Card and Fast Track Scheme.

In 2015 97 percent of all permits granted in the agricultural sector were issued to Ukrainian citizens.

More foreign students attend higher education in Denmark

The number of permits in the area of study increased from 7.425 in 2014 to 8.246 in 2015. The increase is partly a result of more permits being granted to students attending what is defined as other institutions of higher education and to students at Danish universities. In 2015 1.213 permissions were granted to the former group as opposed to 1.092 in 2014. The number of permits granted to the latter group increased from 5.288 in 2014 to 5.333 in 2015.

52 percent of permits granted for educational purposes at Danish universities were granted to students from the USA, whilst 44 percent of the permits issued to students at other institutions of higher education were granted to Nepalese citizens.

In 2015 the number of residence permits issued to au pairs decreased from 1.908 permissions in 2014 to 1.624 in 2015. Also, the number of residence permits issued to interns decreased from 1.542 in 2014 to 1.058 in 2015, whereas the number of permissions granted to the Volunteer and Working Holiday Scheme increased from 710 in 2014 to 982 in 2015.

81 percent of the permits granted to au pairs were issued to Filipino citizens, whilst 68 percent of the permits issued to interns were issued to Ukrainian citizens.

Half of all permits were granted to EU/EEA citizens

The number of residence cards and registration certificates issued to EU/EEA citizens increased from 35.415 in 2014 to 37.366 in 2015, corresponding to a 6 percent increase. The increase is primarily due to an increase in the number of registration certificates issued for the purpose of work, which increased from 16.944 in 2014 to 18.066 in 2015.

The number of registration certificates issued for the purpose of study increased from 9.616 in 2014 to 10.121 in 2015.


The largest nationalities in 2015 in terms of EU/EEA permits were Romania (6.280), Poland (5.991), Germany (3.337), Lithuania (2.589) and Italy (2.285).

Visa

A total of 116.268 visas were issued in 2015. This figure includes 114.112 visas issued by the Ministry of Foreign Affairs and 2.156 visas granted by the Danish Immigration Service.


The three largest nationalities were China (34.756), India (15.552) and Thailand (9.087), counting for more than half of all visas issued in 2015.

The primary purposes of travel by visa in 2015 were tourism and transit (44.653), business reasons (34.270) and visit to family and friends (28.564).




All issued residence permits 2014 - 2015 - broken down by the fifteen largest nationalities in 2015


Overview of a number of key figures 2010 - 2015





Accomodated at the end of 2010 - 2015




Applications for family reunification 2010 - 2015











Visa granted by the Ministry of Foreign Affairs and the Danish Immigration Service 2010 - 2015




Permits for family reunification 2010 - 2015







Residence permits issued for study purposes 2010 - 2015







Residence permits for study purposes broken down by largest categories 2015

The overview, which displays all residence permits etc., does not directly reflect the actual level of immigration to Denmark. Over time an individual can be registered several times in the statistics (double-counting). There can also be cases where a residence permit is not used, because the person concerned never enters the country.

* The chosen categories are: The Pay Limit Scheme, the Fast-Track Scheme and the Corporate Scheme.

** Since 2012 the number of additional work permits granted to students with a student permit is not included. It has been included in previous years. The number of additional work permit to students were 3.410 permits in 2010 and 4.808 permits in 2011.

An introduction to the figures in this overview

• Sources:

The majority of the Danish immigration authorities' statistics are derived on the basis of registrations made in the electronic case and document handling system (ECDH). The ECDH system was taken into use in the first areas in spring 2010 and has gradually replaced the Aliens Register that was phased out in 2014. The data are typically compiled on a monthly or yearly basis.

<u>The digital immigration systems etc.</u>:

The digital immigration systems contain information concerning foreign citizens that have or have had their cases processed, cf. the Immigration Regulation.

The immigration systems are not designed as actual statistical systems. Accordingly, there is some degree of uncertainty attached to the figures. Thus, the compilation of statistics on the basis of information derived from these systems can be cumbersome, either due to technical issues or because the compilation of a certain statistic requires considerable resources to be utilized.

The ECDH system serves as a digital case handling system for all relevant authorities under the Ministry for Immigration, Integration and Housing and the State Administration. The ECHD system is currently utilized in the processing of cases concerning work, study, family reunification, asylum and foreigners included in the EU/EEA regulation.

When compiling the statistics from the ECHD system, in order to provide information to the management and external deliveries, a Business Intelligence (BI) solution is applied.

Statistics regarding visa have been retrieved from the case handling systems IVR-VIS (since 2009) and UM-VIS, which are utilized in the processing of visa cases. IVR-VIS is a part of a greater common electronical visa system used by the Foreign Ministry (the representations), the Danish Immigration Service and the Ministry for Immigration, Integration and Housing.

Historical data regarding decisions issued cf. the Transitional Scheme to citizens of the new EU member states, the Corporate Scheme and to citizens of the EU, who are employed on the Faroe Islands and their accompanying family members, are derived from the Work System (ES), which was taken into use simultaneously with the enlargement of the EU with the new member states on 1 May, 2004.

In January 2012 a new electronic accommodation system (IBS) was taken into use from which it is possible to derive information on accommodated asylum seekers.

Cases regarding the acquisition of Danish citizenship are processed in the Checklist System (TLS).

2012-2015-statistics concerning asylum applications and rejected asylum seekers, who are currently awaiting deportation or have already been transported out, are provided by the Danish National Police on the basis of registrations in POLSAS.

• Use of the immigration authorities' figures:

The immigration authorities' statistics consist of data concerning persons and not cases. The statistics are generally compiled in accordance with the provisions in the Danish Alien Act.

Accordingly, the statistics can first and foremost be seen as administrative statistics, which display how many decisions (events) have been made in cases concerning work, family reunification etc. The information in the systems is limited to the registrations updated by case-handlers. It is important to note, that the number of residence permits in this overview does not directly reflect the actual level of immigration to Denmark. This is primarily due to the following:

1) Over time the same persons can appear in multiple statistical compilations (double-counting). For instance, there can be double-counting between different areas, e.g. if a person who applies for asylum in Denmark already holds a permit on the basis of family reunification. Furthermore, double-counting also exists within the same areas. For instance, if a person who holds a residence permit for the purpose of work or study and changes his/her line of work or study and consequently is granted a new first-time permission.

2) In some instances a residence permit is not used as the person never enters Denmark.

3) The figures include permits granted to work and study on the Faroe Islands and in Greenland. These permits are subject to territorial limitations, and therefore do not allow for the person to stay in Denmark.

4) In some cases there can be a time lag between the time of granting the residence permit and the date of entry into Denmark.

5) Nordic citizens can reside in Denmark without any form of residence permit or registration card. Other EU/EEA citizens can reside in Denmark in up to three months without having to register their residence.

• Methodical remarks concerning the compilation of the figures:

The figures in this publication are based on "calendar figures". A typical example can be statistics, which display the number of decisions within a given area for a certain period of time - e.g. the number of decisions on family reunification made in 2015. However, in many instances it will be relevant to follow a certain group of applicants through parts of or the entire case processing. This is called cohort statistics.

This publication contains information based on applications for first-time residence permits in Denmark. Be aware that a first-time permit does not allow for the beneficiary to reside in Denmark permanently. Accordingly, the residence permit is always limited to a certain period of time. A residence permit can in some instances - and for different lengths of time - be extended.

Accordingly, many foreign residents in Denmark receive more than one permit during the course of their stay (first-time permits, renewals and permanent residency). Thus, the data concerning first-time permits do not give a complete picture of how many decisions are made each year in the field of immigration.

Starting from 2012, the previously used category in the study area 'Work Permits to Students' will not appear in the external statistics. These permits will only be displayed in the historical figures. See the passage on the introduction to the field of study for an in-depth explanation in this regard.

Starting from 2012, statistics concerning decisions made on the basis of the Association Agreement between the EU and Turkey will be accounted for under the category 'Wage-earners in Greenland and on the Faeroe Islands and the Association Agreement'.

• Link to EU statistics on migration:

The Danish immigration authorities provide a series of statistical deliveries to international institutions (e.g. Eurostat, EASO and the UNHCR). The data are submitted on both a regular basis (weekly, monthly, quarterly and yearly) and on an ad hoc basis. In accordance with the EU directive 862/2007 the Danish Immigration Service delivers, like the other EU states, statistics to Eurostat concerning migration and international protection.

The source data, which are the basis of the submissions made to the international statistical partners, are the same as in this publication, but variances may exist in the way in which the different organizations define their statistics compared to how it is done in Denmark. Thus, there might be instances, where the international statistics differ from the Danish ones despite a similar labelling.

The two main differences between the Danish and Eurostat's statistics concerning residence permits are: 1) The Danish statistics contain data on all foreigners, whilst the European statistics as a main rule only include figures

1) The Danish statistics contain data on all foreigners, whilst the European statistics as a main rule only include figures concerning non-EU citizens ("third country nationals").

2) The Danish statistics include all residence permits regardless of their length of validity, whilst the European statistics only contain data regarding residence permits with a validity of at least three months.

Additionally, there are specific variances within different areas:

A) Asylum:

The Danish statistics regarding asylum are limited to information concerning residence permits, which according to the Danish definition are regarded as falling within the asylum area, i.e. refugee status, protection status (the former de factostatus), temporary protection status, quota refugees, humanitarian status, residence permits granted to unaccompanied minors and other reasons.

Conversely, Eurostat's statistics data concerning the asylum area is included in the category "other reasons" – in addition to the asylum area – also contains data regarding residence permits granted on other reasons, for instance residence permits issued to persons included in the rules concerning the Danish minorities, residence permits issued to family members other than children under the age of 15 and spouses/cohabitants, residence permits granted to former Danish citizens, persons of Danish descent and for the purpose of work/study on the Faroe Islands and in Greenland.

B) Family reunification:

The Danish statistics in the area of family reunification includes - in addition to information on family reunification with spouses and children residing in Denmark/Greenland and on the Faroe Island - data on residence permits issued to persons included in the regulation regarding the Danish minorities abroad, residence permits issued to family members other than children under the age of 15 and spouses/cohabitants, residence permits granted to former Danish citizens and persons of Danish descent. In other words, figures that in Eurostat's data are included in the category "other reasons" together with asylum data.

Eurostat's statistics on family reunification also include data on third country nationals that have been granted residence permits on the basis of family reunification with references, who hold permits on the grounds of work or study. In the Danish statistics on the other hand, these types of permits are included in the data concerning permits granted for the purpose of work and study.

C) Work:

The Danish statistics concerning work also include information regarding residencepermits issued to persons on the basis of family reunification with references, who hold permits for the purpose of work. Eurostat's statistics on the other hand do not include these data.

Furthermore, the Danish statistics include data concerning residence permits granted on the basis of permissions to work on the Faroe Island or in Greenland and to the persons, accompanying the former group on the basis of family reunification. Eurostat's statistics do not contain data regarding the latter group.

Finally, the Danish statistics in the area of work do not contain data on residence permits granted to au pairs and interns - information which is included in Eurostat's statistics regarding the area of work.

D) Study:

The Danish Statistics in the area of study include data on residence permits issued to au pairs and interns - these categories are omitted in Eurostat's statistics regarding the area of study.

The Danish statistics also include data on residence permits granted on the basis of family reunification with persons who hold residence permits granted for the purpose of study - on the Faroe Islands and in Greenland too. These categories are not included in Eurostat's statistics regarding the area of study.

E) EU/EEA:

The Danish statistics concerning EU/EEA include all foreigners that have been granted residence cards and registration certificates, whilst Eurostat's statistics only include data on non-EU/EEA (third country nationals).

F) Visa:

The Danish statistics on visa contain information on all foreigners that have applied for visa. The data are submitted to Eurostat in accordance with directive 810/2009.

• Danish compliance with international guidelines for European statistical production:

In January 2015 the Danish immigration Service and two other national authorities underwent a "peer review", where the EU assessed whether the Danish production of European statistics at the national authorities in concern and Statistics Denmark fulfilled the requirements for European statistical production outlined in e.g. the code of practice from 2005 and 2011 (subsequent revision).

The EU concluded that the Danish production of European statistics fulfilled the set criteria, and that it was professional, independent and effective. The review resulted in 23 specific recommendations in four different areas:

- Strengthening the institutional setting (by e.g. adopting new regulation on the production of statistics, new guidelines etc.)

- Securing the sustainability of the national statistical system (by e.g. drafting agreements between Statistics Denmark and the other national authorities, which produce statistics)

- Continuing the efforts to strengthen the quality and the comparability of the activities (e.g. by creating common methodological standards)

- Strengthening the analysis and dissemination (e.g. by creating English versions of the statistics that are most frequently utilized).

Statistics Denmark coordinates the efforts to ensure that the Danish authorities comply with the recommendations - a work which the Danish Immigration Service takes part in too.

Stateless:

The UN convention of 28 September 1954 concerning the status of stateless persons, which Denmark has ratified, contains in article 1, section 1, the following definition of the term stateless person: "For the purpose of this Convention, the term 'stateless person' means a person who is not considered as a national by any State under the operation of its law."

The purpose of the convention is to administer and improve the legal position of those persons who involuntarily have come into the situation that no state recognizes them as nationals. The Convention is not meant to give certain persons the opportunity to choose themselves whether they wish to be nationals of a particular state.

Persons, who seek asylum in Denmark, are registered by the immigration authorities upon arrival. In connection with the initial registration the Danish Immigration Service attempts to ascertain the identity and nationality (citizenship) of the asylum seeker including whether the person is stateless. The registration is based on the asylum seeker's explanation and any written documents etc. In addition, the Danish Immigration Service will take into consideration informations on conditions in the applicant's country of origin. Based on these informations the Danish Immigration Service may alter the registration whilst processing the asylum case.

If a foreigner in Denmark finds that he or she is registered with erroneous data, for example in relation to date of birth or nationality (citizenship) in the records of the immigration authorities, the person can at any time contact the Danish Immigration Service and submit a request for re-registration. The Danish Immigration Service will hereafter make a decision on whether there are grounds for altering the existing records. The latter decision can be appealed to the Ministry of Immigration, Integration and Housing.

Annex 21: Number of permanent residence permits 2010 - 2015

Requirements that have to be fulfilled in order to obtain a permanent residence:

By 5 February 2016 new rules regarding permanent residence were implemented. The rules apply to applications for permanent residence, submitted from 10 December 2015 and onwards.

Prior to the implementation of the new regulation, the following requirements had to be met in order to obtain permanent residency: - The applicant is required to must still qualify for temporary residence

- The applicant is required to be over the age of 18

- The applicant is required to have resided legally in Denmark for at least five years

- The applicant can not have a criminal record. If he or she has been sentenced to more than 18 months in prison, he or she is

disqualified from receiving permanent residency. If he or she has been sentenced to less than 18 months in prison (whether suspended or served), he or she is temporarily disqualified from receiving permanent residence

- The applicant can not have any overdue public debts

- The applicant can not have received certain types of public benefits for a period of three years prior to submitting his/her application for permanent residence, or while his/her application is being processed

- The applicant is required to have submitted a signed declaration of integration and active citizenship in Denmark

- The applicant is required to have passed the Danish language test 1 or a Danish language test of an equivalent or higher level

- The applicant is required to have held a regular full-time employment and/or been enrolled in an educational programme in Denmark for at least three of the five years prior to submitting his/her application for a permanent residence permit

- The applicant is required to be working or studying at the time of becoming eligible for a permanent residence permit

Please note that special rules apply if:


- The applicant has had asylum in Denmark (refugees) for the past eight years, and has shown a willingness to integrate

- The applicant is between the ages of 18 and 19, and has worked or studied continuously since completing primary school (folkeskolen) - The applicant has a strong connection to Denmark

- The applicant is a pensioner or early age pensioner

If the applicant does not meet the requirements for a permanent residence permit, he or she can instead apply for an extension of his/her temporary residence permit and then apply for a permanent residence permit at a later time.

** The main persons are applicants for Danish citizenship, who are listed in a naturalization bill, as they meet the requirements for acquiring Danish citizenship laid down by law. Subordinates are minor-aged children to the main persons. Children only acquire citizenship as subordinates to a main person, if the main person has part of the custody of the child, and if the child is unmarried, resides in Denmark and not subjected to charges of or has committed crime, that cf. circular § 19 excludes the person temporarily or permanently from acquiring citizenship.

Requirements for acquireing Danish citizenship by naturalization for persons who acquired Danish citizenship by naturalization in 2015:

According to the previous circular no. 9253 of 6 Juni 2013 regarding naturalization the following requirements were valid in order to a person to be listed in a naturalization bill:

• the applicant must have been granted permanent residency and reside in Denmark

• the applicant must, as a general rule, have resided continuously in Denmark for at least 9 years

• the applicant must substantiate his or her Danish skills by submitting a certificate of the Danish 3 Examination from the Danish language centres or a corresponding certificate at a similar level

• the applicant must prove to have some knowledge of the Danish society, culture and history by presenting a certificate of a special citizenship test

• the applicant must currently support himself or herself, and can not have received any public cash assistance within the latest year ahead of the introduction of the naturalization bill. Furthermore, the applicant may not, within the past five years, have received any public cash assistance for an aggregated period exceeding six months


• the applicant cannot have overdue debt to public authorities

if the applicant has been sentenced for any criminal offences, the general rule is that he or she can not be listed on a naturalization bill, until the expiration of a certain waiting period, and for some offences it is not at all possible to be listed on a naturalization bill
the applicant has to sign a declaration, in which he or she swears allegiance and loyalty to Denmark and the Danish society, declares willingness to observe Danish legislation and respect fundamental Danish principles of law.

By 5 October 2015 an agreement was made regarding citizenship, which determines new general instructions for issuing bills of naturalization. The new instructions, cf. circular 10873 of 13 October 2015 regarding naturalization, valid from 15 October 2015, have not been used for the applicants who acquired Danish citizenship by naturalization in 2015.

In conformity with UN convention of 20 November 1989 regarding Children's Rights stateless persons born in Denmark are able to be listed in a naturlization bill without meeting the ordinary requirements. However it is required, that the application is submitted before the applicant turns 18, and that the applicant recides in Denmark. The special conditions for this group of applicants are regulated by §§ 17 and 27 in circular no. 10873 of 13 October 2015 regarding naturalization.

Similarily, in conformity with the UN convention of 30 August 1961 regarding Limitation of Statelessness stateless persons born in Denmark, that submit an application after having turned 18 and before turning 21 are able to be listed in a naturalization bill, if they meet the other requirements cf. § 26 in circular no. 10873 of 13 October 2015 regarding naturalization. 

** Decisions regarding other family members can not be separated electronically from decisions regarding spouses and cohabitants in the Aliens Register. In 2010 and 2011 there were 7 and 3 permits respectively granted to children registered in the Aliens Register. These figures are based on manual counting. As of 2011, after commissioning the ECDH system in the area of family reunifications, it has become possible to count decisions according to the EU rules regarding other family members separately.

*** The figures regarding study permits up to 2011 also include work permits granted to foreign students. From 2012 and onwards the number of additional work permits granted to students is not included in the figures displaying student permits. It has been included in prior years. The number of the additional work permits granted to students were 3.410 permits in 2010 and 4.808 permits in 2011.

**** The category volunteer and Working Holiday etc., was earlier defined as "humanitarian work" and also includes cases from other study categories such as Danida stipends and work and residence permits for the purpose of getting an authorization as a doctor or dentist in Denmark.

<u>Note</u>: The overview above, which displayes all residence permits etc., does not directly reflect the actual level of immigration to Denmark. Over time an individual can be stated several times in the statistics (double-counting). There can also be cases where a residence permit is not used, because the person concerned never enters the country.
